The Commission received a complaint on 25.02.2013 from General Secretary, J&K Floriculture Employees and Workers Association against PIO Directorate of Floriculture Kashmir on the grounds that the information sought by them through RTI application dated 22.01.2013 regarding wages of casual labors for the year 2011-12 have not been provided by the PIO.

In response to the notice of the Commission, PIO Directorate of Floriculture, Kashmir, Shri Showkat Ahmad produced copy of order passed by him under letter No. DFK/AS/142 dated 20.02.2013 whereunder following information has been provided: -

2012-13	113.00	99.67	Sep 2011 to June 2012

The RTI application has thus been disposed of within prescribed period.

The Complainant admitted to have received this information but submitted that Casual Labours are disengaged during winter months but from the reading of information it is implied that amount spent includes wages for winter months also, unless details are made available. The complainant submitted that they need monthly details of wages paid to Casual Labours. PIO Directorate of Floriculture Kashmir, who is also Accounts officer of the Directorate, submitted that he will provide month wise details of wages paid to the Casual Labours for period asked for by the information seeker.

The complaint is disposed of with the directions to PIO to provide details of wages as above to the complainants within one week from issue of this under intimation to the Commission.
