The Commission received a complaint on 03.04.2013 from Shri Irshad Ahmad Malik s/o Ali Mohammad Malik r/o Hamdina Colony, Bemina against Tehsildar Pahalgam stating that he approached Tehsildar Pahalgam under RTI Act 2009 on 25.02.2012 but PIO/Tehsildar has not issued the information till date.

Records enclosed with the complaint reveal that complainant filed an RTI application before Tehsildar Pahalgam on 25.02.2013 seeking following information: -

1. "Revenue extracts (certified) of "Jamma Bandi" from year 1937,41,45,49,53,57,61,65,69,73,77,81,85 pertaining to land Khasra No. 345 measuring 3 kanals 14 marlas situated at village Laripora Tehsil Pahalgam District Anantnag.
2. Copy of mutation No. 117-18 pertaining to Khasra No. 345 pertaining to said land dated 11.04.1994 Bikremi (1937)".

Shri Gh. Hassan, Naib-Tehsildar Pahalgam appeared in the Commission and submitted that they received the RTI application of the complaint through PIO/ACR Anantnag on 27.02.2013 and on the same day submitted information to ACR Anantnag along with three leaves as under: -

“As reported by the Patwari concerned, the record stands gutted of 1937 to 1985. So that record is not available with the Patwari. Copy of the current record i.e. abstracts of jamabandi and girdari and map is hereby submitted as desired”.

The Commission has, noted that the complainant filed same application concurrently before ACR Anantnag and Tehsildar Pahalgam on 25.02.2013. ACR Anantnag transferred the RTI application filed before him to Tehsildar Pahalgam vide letter dated 25.02.2013. Tehsildar Pahalgam sent the information to ACR Anantnag on 27.02.2013, who in turn has supplied the same to the information seeker. The information seeker admitted to have received the information.

In view of above, the RTI application has been responded to in time and complaint stands dismissed.

With regard to submission of complainant that he is not satisfied with the information, he is advised to file an appeal before FAA Office of Deputy Commissioner Anantnag. Since complaint filed before the Commission has been heard and decided today, FAA Office of Deputy Commissioner Anantnag is directed to admit first appeal, if any, filed by the complainant within two weeks from issue of this order.
