The Commission received an undated complaint on 21.06.2013 from Mohammad Shabir Mir s/o Dost Mohammad r/o Jibla Tehsil Uri against Tehsildar Uri stating he filed an RTI application before Tehsildar Uri seeking information regarding land details of one Bashir Ahmad Mir s/o Abdullah.

The complainant has enclosed an undated RTI application and treasury receipt dated 16.10.2012 with the complaint. Therefore complaint has been made 08 months after deposition of fee in the Treasury. However there is no evidence/proof of receipt of RTI application by PIO.

In the RTI application the complainant has sought information regarding land under Khasra No. 31 of Bashir Ahmad Mir resident of Zibla besides he has

alleged that more than 57 kanals of land have been entered in the name of Bashir Ahmad Mir by tampering of records by revenue official.

Tehsildar Uri Shri Mohammad Aslam Chauhan appeared before the Commission submitted that they have not received the RTI application under reference. That RTI application came to his notice only when he received the notice of the Commission, to which RTI application was enclosed. In his written reply he submitted that on receipt of complaint from the Commission alongwith the notice dated 02.07.2013, he compiled information comprising of 7 pages and provided to the complainant on 16.07.2013 under proper receipt on the receipt register.

The Commission has noted that complainant has not enclosed/produced any evidence of the RTI application being received by the Tehsildar Uri's Office and that the complaint has been filed after delay of 8 months. Accordingly, explanation of Tehsildar Uri is accepted and complaint is disposed of. It has further been noted that this information pertains to 3rd party regarding revenue extracts and Tehsildar Uri ought to have followed procedure as laid down under the J&K RTI Act for 3rd party information.
