Briefly the facts in this appeal are that Sh. Om Parkash S/o Sh. Kunj Lal R/o Ajna, Pullar moved an application dated 26-07-2013 before the PIO/Child Development Project Officer, Block Nagseni, Kishtwar under J&K RTI Act, 2009 whereunder he sought the following information:-

1. Request for issuance of detail of funds received and utilized in Block Nagseni during the year 2009, 2010, 2011, 2012 upto March 2013 ending.
2. Request reply regarding the sanctioned exact location of AWC Ajna and presently functioned show location.
3. Request for issuance of certified, copy of GPR for the year 2009 to 2013 ending.

4. Total nutrition received and disbursed during the year 2009 to 2013 and details of carriage/fuel, drawn during the year 2009 to 2013 ending.
5. Details of enrolment of children in AWC Ajna, Pullar with name and parentage.

During the course of proceedings held today, the District Social Welfare Officer, Kishtwar/PIO and Child Development Project Officer, Block Nagseni, Kishtwar submitted an affidavit dated 20-12-2013 duly signed by the information seeker and sworn before a public Notary District Court, Kishtwar whereunder he has submitted that Child Development Project Officer has provided the requisite information sought by him under RTI Act, 2009 and he is fully satisfied with the same. The information seeker has also requested for withdrawal of the application under RTI Act and has further submitted that he will not claim the said information again.

Perusal of the record shows that the Child Development Project Officer, Block Nagseni, Kishtwar furnished the requisite information through post vide letter No:CDPO/N/13/115-17 dated 07-10-2013. The information was again furnished to the applicant personally on 14-12-2013 containing 33 leaves as enclosures which has been duly acknowledged by the applicant. However, there is delay in furnishing the information to the information seeker which has been justified by the PIO due to law and order problem prevailing in Kishtwar during that period and also due to retirement of the then CDPO.

In the given circumstances, there appears to be no intentional delay or malafide on the part of the PIO in providing the information to the information seeker. The information already stands furnished to the information seeker. Hence, no direction in the matter is required.

The appeal is accordingly disposed of.

Notice of this decision be given free of cost to the parties.
