Briefly the facts in this appeal are that Sh. Mohinder Pal S/o Sh. Thakar Dass R/o Katwalat P/o Sudmahadev, Tehsil Chenani, District Udhampur moved an application dated 07-08-2013 before the PIO, Tehsil Supply Officer, Chenani under J&K RTI Act, 2009 whereunder he sought certain information relating to genuineness of BPL card holders and APL, AAY card holders of Katwalat Panchayat.

The PIO vide office No:681/TSO dated 23-08-2013 requested the information seeker to deposit an amount of Rs.5000/- as cost of information. Subsequently on the request of the information seeker and scrutiny of available office record the Asstt. Director, CA&PD Udhampur vide office No:1246/AD/CAPD/Udh dated 9-11-2013 requested the appellant to deposit an amount of Rs. 314/- only as cost of information in the treasury under MH-4408. In compliance to the aforesaid direction of AD, CAPD Udhampur, the information

seeker deposited the cost of information and consequently the information comprising (157) leaves was sent to the information seeker under a registered cover vide office No:1317/AD/CAPD/Udh dated 20-11-2013.

However, the information seeker was not satisfied with the information provided to him and preferred appeal dated 9-12-2013 before the Commission in which he has alleged that the information provided by PIO/TSO Chenani is not based on facts and is totally misleading. During the course of proceedings held today, TSO,Chenani and AD, CA&PD, Udhampur apprised the Commission that the information which has been provided to the information seeker is factually correct and based on office record and also submitted that in case the information seeker is interested in inspecting the record, he is at liberty to do the same in the office of TSO Chenani on a working day during office hours.

In view of the aforesaid facts and observations, PIO/TSO Chenani is hereby directed to provide an opportunity to the information seeker to inspect the record in his office on a working day and in case the information seeker requires the photocopies of relevant documents that may be provided to him on payment of requisite fee as prescribed under the Act. The parties are at liberty to settle the date and time for inspection of record which may be convenient to them.

The appeal is accordingly disposed of.

Notice of this decision be given free of cost to the parties.
