Briefly the facts in this appeal are that Sh. Sudesh Kumar S/o Sh. Perma Nand R/o Dhalli, Tehsil Hiranagar, District Kathua moved an application dated 30-8-2013 before the PIO/Director Rural Development Department, Jammu under J&K RTI Act, 2009 whereunder he sought certain information.

The PIO/BDO Hiranagar vide No:BDO/Hgr/2013-14/1805-06 dated 30-09-2013 furnished the requisite information to the information seeker pointwise. However, the information seeker was not satisfied with the information provided to him and preferred Ist appeal before Director Rural Development Department, Jammu which was adjudicated and disposed of vide No:DRDJ/RTI-359/2013/15063-67 dated 07-11-2013. Feeling aggrieved of the aforesaid order, the information seeker filed second appeal dated 9-12-2013 before the

Commission. The matter was listed for hearing on 16-01-2014 at Jammu office of the Commission.

During the course of proceedings held today, the information provided by the PIO to the information seeker as per RTI application was discussed threadbare. The information seeker brought to the notice of the Commission that information relating to query No. 1, 8 and 11 provided to him by the PIO is incomplete and deficient in nature and requested that they be directed to provide the revised information relating to these queries.

Keeping in view the aforesaid facts and observations and also the request of the information seeker, the PIO (ACD Kathua) and BDO Hiranagar are hereby directed to furnish the revised information free of cost to the information seeker within 10 days from the date of receipt of this order under an intimation to the Commission. The PIO/BDO is also directed to allow the appellant an opportunity to inspect the record in his office on a working day during office hours and provide him photocopies of the relevant documents if any requested by him. The parties are at liberty to settle the date and time for inspection of record which may be convenient to both of them.

The appeal is accordingly disposed of.

Notice of this decision be given free of cost to the parties.
