Briefly the facts in this appeal are that Sh. Tara Chand S/o Sh. Natho Ram R/o Village Balooni, P.O. Jatwal, Block Ghagwal, Tehsil & Distt. Samba, moved an application dated 20-08-2013 under J&K Right to Information Act, 2009 before the PIO, Directorate of Social Welfare Department, Jammu whereunder he sought certain information relating to the posts of Anganwari Workers for AWCs in Block Ghagwal, Tehsil Samba in pursuance to the advertisement notice dated 05-02-2010 published in State Times News Paper.

Feeling aggrieved of inaction on the part of the PIO, the information seeker preferred 1st appeal dated 18-09-2013 before the FAA/Director, Social Welfare Department, Jammu which was disposed of vide order No. DSWJ/ICDS/20311-

15/13 dated 24-10-2013 with the direction that information available with the concerned offices (award sheet duly signed by the committee members) be provided to the appellant.

During the course of proceedings held today, the PIO/Child Development Project Officer, Gagwal apprised the Commission that the requisite information has been provided to the applicant as per office record through registry vide office letter no. CDPO/G/2013-14/306 dated 11-09-2013. The PIO further submitted that the individual handwritten award sheets of each Committee Member is not available in our office record, but consolidated list showing individual marks given by each Committee Member is available and was provided to the information seeker. Thus the information sought already stands furnished to the information seeker. No direction in the matter is required.

The appeal is accordingly disposed of.

Notice of this decision be given free of cost to the parties.
