Briefly the facts in this appeal are that Sh. Darshan Singh Modi R/o No. 1 Sarwal, New Plots, Jammu Tawi-180005 moved an application dated 27-05-2013 under J&K Right to Information Act, 2009 before the PIO O/o Deputy Commissioner, Jammu whereunder he sought the following information:-

- 1. In the matter of Court case, you have constituted rent assessment committee vide your Order No. DCJ/LHS/LV/JMU/Purkhoo 33/91 dated 20-10-2011 for the assessment of the rent of our land occupied by the relief organization. In this order you have asked committee to submit the report within one week for fixing of rent.*
 - a. Please inform me what action has been taken so far. If no action is taken what is the reason behind it.*
 - b. Who is accountable for so much delay?*
 - c. When rent will be fixed? Copy of your order is enclosed here for ready reference.*
- 2. Relief organization has written so many letters to the Assistant Commissioner (R) DC Office Jammu for their letter no. RCM/Legal/12/2062 dated 02-02-2012 RCM Legal/12/2064 dated 11-02-2012 RCM Legal/12/2070 dated 19-03-2012 RCM Legal/12/2107 dated 21-09-2012 and RRCM Legal/12/2/20 dated 08-12-2012 RRCM/Legal/13/2132 dated 22-01-2013 for demarcation of our land at Purkhoo.*

- a. *What action has been taken in these letters and if not what is reason behind not doing requisite demarcation/*
- b. *Who is responsible for not performing his duty?*
- c. *When will be the demarcation to land will be done? Latest copy of Relief Commissioner addressed to AC Revenue is attached for ready reference.*

The PIO/AC(R), Jammu vide office letter no. DCJ/LHS/Army/RoR-91/91 dated 31-07-2013 communicated the information to the information seeker sought in his RTI application. However, feeling aggrieved of the aforesaid order of the PIO, the information seeker preferred 1st appeal before the FAA/Deputy Commissioner, The FAA disposed of the 1st appeal on 20-09-2013 with the direction to PIO to provide the information which stands already provided to the applicant under above reference and further with the direction to Asst. Commissioner (Revenue), Jammu to dispose of the grievances of the applicant if any. The aforesaid letter have been brought on record.

The Commission after receiving the 2nd appeal listed the matter for hearing on 27-01-2014 at Jammu office of the Commission. During the Course of proceedings held today, the information seeker brought to the notice of the Commission that he requires a certified copy of SRO 104 of 2008 dated 11-04-2008 relating to rental compensation. The PIO agreed to provide the same and requested the information seeker to collect from his office. In view of the aforesaid facts and observations, the information as sought by the information seeker and as available in office record stands already furnished to him. Thus, no further direction in the matter is required.

The appeal is accordingly disposed of.
