Briefly the facts in this appeal are that Sh. Mohinder Kumar Sharma R/o House No. 87, Sector-3, Sanjay Nagar Jammu moved an application dated 08-08-2013 before the PIO/ Tehsildar Settlement, Billawar District Kathua under J&K Right to Information Act, 2009 whereunder he sought the following information :-

1. Copy of Mutation of gift deed attested in Khasra No. 989,990,991 of village Dadwara (Bhaddu) gifted by Sh. Ishar Dass to his sons Mr. Mohinder Kumar Sharma, Mr. Jia Lal Sharma and Mr. Darshan Kumar Sharma.
2. Copy of Khasra Girdawari of Kh. No. 989,990,991 of village Dadrara (Bhaddu) after attestation of mutation of gift deed to till date.
3. Certified copy of statement of Mohinder Kumar Sharma given on 25-07-2013 in camp at village Dadwara in case regarding the consent for change of Girdawari on the name of Darshan Kumar Sharma on the application of his father Sh. Ishar Dass Sharma.

The PIO/Tehsildar Settlement, Billawar vide office No:376/STB/13-14 dated 03-09-2013 informed the applicant to apply for the certified copies of above said documents in person or through recognized agent duly authorized under

law and also pay the requisite fee under the provisions of Stamp Duty Act in order to get these documents. Meanwhile, the PIO vide office No:443/STB/13-14 dated 18-10-2013 furnished the photocopies of the information sought by the information seeker on the direction of SDM Billawar.

During the course of proceedings held today, the appellant insisted that PIO be directed to provide certified copies of the aforesaid documents and also agreed to pay the requisite fee as prescribed under rules. The PIO advised the applicant that incase he is interested in getting certified copies of the aforesaid documents, he has to pay the fee of Rs. 20/- for each document vide treasury receipt under head 0029 LR. The appellant agreed to do the needful as per the advice of PIO.

Keeping in view the aforesaid facts and observations, the PIO/Tehsildar Settlement, Billawar is hereby directed to provide the certified copies of the aforesaid documents within a week's time after receipt of the request of the appellant subject to production of treasury receipt under head 0029 LR as an evidence of payment of fee prescribed under rules.

The appeal is accordingly disposed of.

Notice of this decision be given free of cost to the parties.
