## Jammu 30-01-2014

Briefly the facts in this appeal are that Sh. Chur Chand Sharma, Sr. Asstt., HSS Gundna, Doda moved an application dated 27-08-2013 before the PIO/ Joint Director, Directorate of School Education, Jammu under J&K Right to Information Act, 2009 whereunder he sought the following information:-

- 1. Action taken report on my representation received vide receipt No. 13972 dated 16-01-2013 and No. 15011 dated 04-02-2013.
- 2. Vacancy of Head Assistant at the time of DPC's meeting held on 25-08-2012 and 26-08-2012 at Directorate of School Education, Jammu.
- 3. Service particulars of 65 Senior Assistants cleared by the DPC for promotion as I/c Head Assistant held on 25-08-2012 and 26-08-2012 published in Newspaper dated 04-09-2012.
- 4. Service Particulars of 61 Senior Assistants placed as I/c Head Assistant published in Newspaper dated 03-01-2013.

- 5. Action taken report on the representation of Sarpanchs of Block Gundna issued by the Administrative Department vide No. Edu-II/291/2012 dated 15-01-2013.
- 6. Action taken report of Administrative Department letter Edu-26-II/291/2012 dated 5-04-2013.
- 7. Action Taken report of Chief Education Officer, Doda's recommendation made vide CEO/D/Estt/6534-35 dated 01-06-2013 received in Directorate of School Education vide receipt No. 2865 dated 08-06-2013.
- 8. Latest vacancy Head Assistant in Jammu Division as on 08/13.

The PIO vide office letter No:DSEJ/RTI/2014/8038 dated 08-01-2014 filed the counter statement before the Commission in which he has stated that file of the information seeker was referred to the non-gazetted section of the Directorate and on re-submission the information was received from the concerned section. The information seeker was telephonically informed to collect the information on 04-10-2013. However, the information seeker collected the information by hand on 05-11-2013 and pointed out that information relating to query Nos. 1, 7 and 8 of the RTI application remains pending and requested that it may also be furnished. The PIO further informed the Commission that for the pending information the case file of the information seeker was again referred to nongazetted section with the direction to provide the requisite information at the earliest as the appellant was already in Ist appeal before the Director School Education, Jammu and on re-submission the concerned section provided the original file of the applicant. On the same day, the information seeker was telephonically informed regarding the original file received by the RTI section and was requested to collect the desired information on 18-12-2013 as contained in the original file.

However, during the course of proceedings held today, the information seeker has alleged that the information regarding query Nos. 1, 7 and 8 is incomplete and he has not been provided any information relating to action taken report on his representations dated 16-01-2013, 4-02-2013 and 8-06-2013.

Keeping in view the aforesaid facts and observations and request of the information seeker, the PIO/Jt. Director, Directorate of School Education, Jammu is hereby directed to furnish the revised information relating to query Nos. 1, 7

and 8 as raised by the information seeker in his RTI application within one week from the date of pronouncement of this order under an intimation to the Commission.

The appeal is accordingly disposed of.

Notice of this decision be given free of cost to the parties.
