Briefly the facts in this appeal are that Sh. Yog Raj Sen S/o Late Sh. Prehlad Bhagat R/o Zelana Lachdayaram, Tehsil & District Kishtwar moved an application dated 18.06.2013 under J&K RTI Act, 2009 before the PIO, Revenue Department, Kishtwar whereunder he sought certain information relating to construction of Technical Shed to Bandarna Link Road.

After receiving the application of the information seeker, Tehsildar/APIO, Kishtwar vide office letter no. 66/VER/OQ dated 25-07-2013 furnished the requisite information to ADC, Kishtwar which was further endorsed to the information seeker. The Collector Land Acquisition, Kishtwar vide office letter no. ACR/LA/2013/741 dated 07-08-2013 also furnished the requisite information to the information seeker as sought by him in the RTI application. However, the information seeker was not satisfied with the information provided to him preferred 1st appeal dated 24-09-2013 before District Development Commissioner, Kishtwar. The perusal of record shows that 1st appeal has not been adjudicated and disposed of till date. Thus, feeling aggrieved of inaction

on the part of the FAA, the information seeker preferred 2nd appeal dated 24-10-2013 before the Commission wherein he has alleged that the PIO has furnished him incomplete information. The Commission after receiving 2nd appeal, listed the matter for hearing on 10-02-2014 at Jammu office of the Commission. During the course of proceedings held today, the APIO/Tehsildar, Kishtwar was present. The appellant was contacted telephonically and he informed the Commission that he has not received the copy of Masvi/Latha of Lachkhazana/Lachdayaram. The Tehsildar/APIO, Kishtwar apprised the Commission that neither Masvi nor Latha of Lachkhazana/Lachdayaram is available in his office, hence they are unable to provide the said information to the information seeker.

Keeping in view of the aforesaid facts, it is apparent that the said record is not available in the office and hence the information as sought by the information seeker cannot be furnished to him. No direction in the matter is required.

The appeal is accordingly disposed of.
