Briefly the facts in this appeal are that Sh. Shashi Paul Sharma S/o Sh. Bal Krishan Sharma R/o Bhaiya, P.O. Satura, Tehsil Hiranagar & District Kathua moved an application dated 30.09.2013 under J&K RTI Act, 2009 before the PIO O/o Tehsildar, Jammu whereunder he sought the following information:-

- 1. Kindly provide the copies of the fards issued with regard to land bearing khasra nos-590, 590min, 592,1 situated at Rajpura, Block-Marh, Tehsil & Distt. Jammu since 2006 till date.*
- 2. Kindly also provide the latest copies of the khasra girdawaries of the land bearing khasra nos 583, 584, 590, 590min, 592,1 situated at Rajpura Block-Marh, Tehsil & Distt. Jammu with details of the levy collected by the department with regard to khasra no. 583 for the financial years 2012-13 & 2013-14.*
- 3. Kindly also provide the posting details for last 10 years of Sh. Sat Paul presently posted as Naib-Tehsildar Marh with details of the posts held and place of postings.*

Feeling aggrieved of inaction on the part of the PIO, the information seeker filed 1st appeal dated 11-11-2013 before the FAA O/o the Deputy Commissioner, Jammu which was disposed of vide order no. ACR/FAA/RTI/2013-14/47-50 dated 27-11-2013 with a direction to the PIO / Tehsildar(S), Jammu to provide the

requisite information to the information seeker within two weeks from the date of receipt of this order. Feeling aggrieved of the aforesaid order, the appellant filed 2nd appeal dated 31-12-2013 before the Commission. After receiving the 2nd appeal, matter was listed for hearing on 11-02-2014 at Jammu office of the Commission.

During the course of proceedings held today, Tehsildar(S), Jammu informed the Commission that the requisite information as sought by the information seeker in his RTI application was dispatched to him on 10-12-2013. However, the counsel for the appellant Sh. Kovid Khosla was contacted on telephone and he apprised the Commission that the information provided by the PIO/Tehsildar(S), Jammu is incomplete as it does not cover all the khasra nos about which the information is sought in the RTI application. The Tehsildar(S), Jammu agreed to provide the revised information to the information seeker and sought one week time for the same.

In view of the aforesaid facts and observations, Tehsildar(S), Jammu is hereby directed to furnish the revised and complete information to the information seeker within a week's time from the date of receipt of this order under an intimation to the Commission.

The appeal is accordingly disposed of.

Notice of this decision be given free of cost to the parties.
