Briefly the facts in this complaint are that Sh. Lakhan Paul Sharma S/o Sh. Bhagat Ram R/o Chhan Rorian, Tehsil Hiranagar & Distt. Kathua moved an application under J&K RTI Act, 2009 before the PIO O/o Directorate of School Education, whereunder he sought information relating to educational qualifications of certain persons who were appointed as Library/Laboratory Assistants pursuant to Advertisement notice no. 1 of 1992 dated 11-06-1992.

After receiving the RTI application of the information seeker, the PIO referred the case file to Personnel officer of the Directorate who further referred the case file to CEO, Kathua vide office letter no. DSEJ/Gen/7396-97 dated 28-10-2011 with the request to furnish the requisite information to the Directorate office through return fax/email. After receiving the information from PIO/CEO, Kathua, the information sought was provided to the information seeker vide letter no. DSEJ/RTI/2012/1043-45 dated 02-02-2012. The perusal of the office record shows

that the information was collected by the information seeker personally on 06-08-2012 through counsel Sh. M.N. Mughal.

During the course of proceedings held today, Sh. Bhanu Pratap Singh(Advocate) who appeared on behalf of the complainant requested the Commission that the information provided to the applicant is not as per his RTI application and prayed that the information as requested in the RTI application may be provided to him. Sh. Virender Nath Sharma, Lecturer who appeared on behalf of the PIO/Joint Director, Directorate of School Education Jammu assured the Commission that he will take up the matter with CEO, Kathua and ensure that the information as sought by the information seeker in his RTI application shall be made available to him and requested for two week's time to do the needful in the matter.

In view of the aforesaid facts and observations, PIO / Joint Director, Directorate of School Education, Jammu is hereby directed to dispose of the RTI application of the information seeker within two week's from the date of receipt of this order under an intimation to the Commission

The complaint is accordingly disposed of.

Notice of this decision be given free of cost to the parties.
