Briefly the facts in this appeal are that Mrs. Masooma Ayan, Ex. Sarpanch, Panchayat Halqa Bathai, Tehsil Mahore & Distt. Reasi moved an application dated 17-08-2013 under J&K RTI Act, 2009 before the PIO/CEO, Reasi whereunder she sought certain information.

The PIO/CEO, Reasi vide office letter no. CEO/Rsi/RTI/6841-42 dated 24-08-2013 requested the information seeker to deposit a sum of approximately Rs. 500/- in the shape of treasury receipt under account head-0070/- within the stipulated period of time, so that the process of compilation of the information shall be initiated, accordingly. The PIO/CEO, Reasi further informed the information seeker that rest of the amount shall be intimated at the time of compilation of requisite information from the concerned quarters. The ZEO, Mahore vide office letter no. ZEO/M/2221-27 dated 31-08-2013 reminded the information seeker to deposit the requisite amount so that the information may be dispatched within the statutory period. The information

seeker accordingly deposited the requisite amount and the information was provided to him. During the course of proceedings held today, Sh. Mohd. Ayub Ayan who appeared on behalf of the appellant informed the Commission that the information provided to the information seeker is incomplete and irrelevant and is not in consonance with her RTI application. The CEO, Reasi / ZEO, Mahore agreed to re-furnish the information to the information seeker as sought in the RTI application and sought ten days time to do the needful.

In view of the aforesaid facts and observations, CEO, Reasi / ZEO, Mahore are hereby directed to provide the revised information duly certified as per office record and free of cost to the information seeker within ten days from the date of receipt of this order under an intimation to the Commission

The appeal is accordingly disposed of.

Notice of this decision be given free of cost to the parties.
