Briefly the facts in this appeal are that Sh. Abdul Majid S/o Elam Din R/o W. No. 3 Ardhanipond Lane No. 2, Madina Hill Bathindi, Jammu moved an application dated 08-06-2013 before the PIO/Tehsildar, Bishnah under J&K RTI Act, 2009 whereunder he sought the following information:-

1. The copies of sale deed under which an area of 1 Kanal 16 marlas under Khasra No. 825, 826 was sold by Smt. Sakina Bi wd/o Ramzan Tehsil Bishnah.
2. The copies of Mutation under which such sold area was transferred in the name of purchaser.
3. Copies of Fard Intikhab/Tatima Shajra within her share showing the area sold by Smt. Sakina Bi to the so called purchaser Ajmar Singh S/o Gul Chain Singh and the balance area left without sale.
4. The copy of the report of Mr. Suram Singh Ex. Patwari alongwith copy of the application presented by the seller for obtaining necessary documents for sale of land.

The PIO/Tehsildar, Bishnah furnished the requisite information to the information seeker on 03-09-2013 vide No:215/OQ. However, the information seeker was not satisfied with the information provided to him, preferred Ist appeal dated 19-09-2013 before the Addl. Dy. Commissioner, Jammu which was

accordingly disposed off vide order No:ACR/FAA/RTI/2013-14/14-16 dated 06-11-2013 with the direction to the PIO/Tehsildar, Bishnah to provide the information to the information seeker within two weeks on prescribed Format under intimation to the FAA. Accordingly, the PIO/Tehsildar Bishnah as per aforesaid order of the FAA provided the requisite information to the information seeker. However, the information seeker was not satisfied with the information provided to him, preferred second appeal dated 11-12-2013 before the Commission.

After receiving the appeal of the appellant, the matter was listed for hearing at Jammu office of the Commission on 17-02-2014 . Both the parties were present. During the course of proceedings, Tehsildar, Bishnah apprised the Commission that the information as directed by the FAA had already been furnished to the information seeker. The PIO further submitted that in case the appellant is interested in inspecting the record, a facility to do the same will be provided to him.

In view of the aforesaid facts and observations, PIO/Tehsildar, Bishnah is hereby directed to allow the appellant an opportunity to inspect the record in his office on a working day and provide him the certified copies of the relevant documents if any required by the appellant on payment of requisite fee as prescribed under the revenue laws. The parties are at liberty to settle the date and time for inspection of record which may be convenient to both of them.

The appeal is accordingly disposed of.

Notice of this decision be given free of cost to the parties.
