Briefly the facts in this appeal are that Sh. Mohd. Riaz R/o H.No. 11/1, Mohalla Ramzanpur, Janipura, Jammu-180007 moved an application dated 01.08.2013 under J&K RTI Act, 2009 before the PIO O/o Sr. Superintendent of Police, Jammu whereunder he sought the following information:-

- 1. What are the findings of enquiry officer appointed against Head Constable Rehmatullah No. 1272/J P/S Pacca Danga, Jammu in FIR No. 119/2011.*
- 2. Kindly provide the detailed report/information regarding latest position of the above said case/FIR No. 119/2011.*
- 3. Kindly provide the certified copy of findings of inquiry officer initiated against H.C. Rehmatullah No. 1272/J P/S Pacca Danga, Jammu in FIR No. 119/2011.*

Supdt. of Police, City North, Jammu vide office letter no. 11162/SPCN dated 30-08-2013 furnished the information to Dy. Supdt. of Police, Hqrs./PIO, Jammu which the later provided to the information seeker accordingly. However, the information seeker was not satisfied with the information provided to him and preferred 1st appeal dated 10-10-2013 before the FAA, PHQ, Jammu instead of S.P. Hqrs./FAA, Distt. Jammu. Since the

information was pertaining to District Police, Jammu, the information seeker was advised to approach the FAA/DPO, Jammu for the requisite information vide headquarters communication No. PHQ/FAA/RTI/MF-04/2013/254 dated 18-11-2013. After receiving the aforesaid letter, the information seeker preferred 2nd appeal dated 30-12-2013 before the Commission in which he has alleged that the information provided to him by the PIO was incomplete and not as per his RTI application. The Commission after receiving the 2nd appeal listed the matter for hearing at Jammu office of the Commission on 19-02-2014. Both the parties were present.

During the course of proceedings, the appellant submitted before the Commission that he has not been provided the certified copy of enquiry initiated against Head Constable Rehmatullah No. 1272/J, P/S Pacca Danga, Jammu in FIR No. 119/2011. The PIO agreed to furnish the requisite information as sought by the information seeker in his RTI application and sought 10 days time to provide the same.

In view of the aforesaid facts & observations, PIO/Dy.S.P. Hqrs, Jammu is hereby directed to furnish the certified copy of the enquiry report conducted against Head Constable Rehmatullah No. 1272/J, P/S Pacca Danga, Jammu in FIR No. 119/2011 within 10 days from the date of receipt of this order under an intimation to the Commission.

The appeal is accordingly disposed of.

Notice of this decision be given free of cost to the parties.
