The Commission vide its order No:SIC/J/92/2013/116 dated 09-05-2013 directed the PIO/Addl. Dy. Commissioner, Kishtwar to provide the certified copies of service book of Sh. R.K Shavan the then Addl. Dy. Commissioner, Kishtwar after severing if required under section 10(1) of the Right to Information Act any information that may be considered as personal and is exempted from disclosure under section 8(1) (i) of the Right to Information Act. The complainant filed a complaint through Sh. Aseem Sawhney, Advocate alleging therein the non-compliance of the aforesaid order of the Commission by the PIO/Addl. Dy. Commissioner, Kishtwar.

The Commission after receiving the complaint for non-compliance sought explanation of the PIO/Addl. Dy. Commissioner, Kishtwar who vide office No:1686-87/ADC/K/2014 dated 18-01-2014 informed the Commission that Sajjad Ahmed Najjar was requested vide office No:REV/RTI/91/2013 dated 03-06-2013 to attend his office on any working day for collection of information, but he refused to sign the letter/summon with the plea that he will collect any information as and when it will be required by him. The PIO further submitted that again vide office No:989/ADC/K/2013 dated 24-06-2013, the complainant was requested to attend

his office for collection of information sought by him but again he did not turn up. The PIO also informed the Commission that copy of service book of Sh. R.K Shavan the then Addl. Dy. Commissioner, Kishtwar containing 13 leaves was sent to the complainant through a registered post at the Kishtwar address of the complainant vide office letter No:65-66/ADC/K/2013 dated 20-07-2013 and receipt No:ARE828089733 IN dated 22-07-2013.

The learned counsel for the complainant during the course of proceedings alleged that the information which was sent to his client under a registered cover contained only irrelevant papers and not the information sought in the RTI application. During the course of proceedings, the PIO/Addl. Dy. Commissioner, Kishtwar assured the Commission that he will send the certified copy of the service book of Sh. R.K Shavan the then Addl. Dy. Commissioner, Kishtwar under a registered cover at the address of Sh. Aseem Sawhney Advocate, learned counsel for the complainant within a week's time from the date of pronouncement of this order. The PIO is hereby directed to follow the direction of the Commission and ensure that it is implemented in letter and spirit.

The Complaint for non-compliance is accordingly disposed of.

Notice of this decision be given free of cost to the parties.
