Briefly the facts in this complaint are that Sh. Kabla Singh, Retired Master R/o Jawahar Nagar, Ward No.01, Kathua moved an application dated 16-09-2013 before the Commissioner/Secretary to Government, J&K Education Department, Srinagar under J&K Right to Information Act, 2009 whereunder he sought certain information relating to upgradation of Tiny Scholars Senior Secondary School, Jawahar Nagar, Ward No. 1, Kathua of 10+2 classes alongwith the inspection report.

The complainant has alleged in his complaint dated 5-11-2013 before the Commission that he has not been provided a copy of sanctionorder of upgradation of Tiny Scholars Senior Secondary School, Jawahar Nagar, Ward No. 1 Kathua of 10+2 classes. Though the information seeker has acknowledged the

receipt of inspection report vide No:DSEJ/RTI/6345-48 dated 16-07-2013 from the Director School Education Jammu. The Chief Education Officer, Kathua vide counter statement No:CEOK/RTI/224 dated 22-02-2014 informed the Commission that entire information sought by the complainant has been furnished to him from time to time and nothing has been concealed. The Government Order No:508-Edu of 2013 dated 25-04-2013 whereunder Tiny Scholars Senior Secondary School, was granted recognition of upgradation for running classes upto 12<sup>th</sup> standard in Science and Arts stream till March, 2012 has already been furnished to the information seeker. The PIO/Directorate of School Education, Jammu vide office letter No:DSEJ/RTI/2013/7591 dated 02-12-2013 also informed the Commission that the requisite information as sought by the information seeker stands provided to him by the CEO Kathua vide letter No:CEOK/RTI/21573 dated 07-10-2013 and Secretary to Government, School Education Department, Civil Secretariat, Srinagar was also informed vide letter No:DSEJ/Pvt./RTI/5308-09 dated 19-10-2013 about the same.

In view of the aforesaid facts and observations, it is apparent that the information as sought by the information seeker stands furnished to him within the statutory period. No further direction in the matter is required.

The Complaint is accordingly disposed of.

Notice of this decision be given free of cost to the parties.
