Briefly the facts in this appeal are that Sh. Chajju Ram Fotra R/o VPO Naran, Tehsil and District Samba moved an application dated 23-05-2013 before the PIO/Chief Education Officer, Samba under J&K Right to Information Act, 2009 whereunder he sought the following information :-

clerk posts and has effected the students studies, besides transfers of 12 Teachers had been made from Govt. Primary School Naran, Khawara, Trelli, Muthi Kalan, Muthi Khurd and Madhra without their substitutes and public has withdrawn their children and have sent to them in private institutes.

- v. Why vacant posts shown above in Primary schools has not been filled up under R-e-T scheme or have referred including High School to SSB so unemployed local youth can get the benefit of these posts.
- vi. A copy of Govt./Director Education orders be supplied where you have authorized to retain the overstay staff more than 3 years at one place in Govt. High, Middle, Primary Schools mentioned above.

The PIO/Chief Education Officer, Samba furnished the requisite information to the information seeker vide No:CEOS/4619 dated 22-06-2013. However, the information seeker was not satisfied with the information provided to him preferred Ist appeal Dated 14-11-2013 before Directorate of School Education, Jammu. After that the information seeker filed second appeal dated 08-01-2014 before the Commission. The matter was listed for hearing on 26-02-2014 at Jammu office of the Commission. Both the parties were present. During the course of proceedings, appellant apprised the Commission that the information provided to him relating to query No.(v) is vague and uncertain and requested the Commission that the PIO be directed to furnish the revised information. The PIO also agreed to furnish the revised information relating to query No.(v).

Keeping in view the aforesaid facts and observations, the PIO/CEO Samba is hereby directed to furnish the revised information relating to query No. (v) requested by the information seeker in his RTI application as available in office record and free of cost within one week

from the date of receipt of this order under an intimation to the Commission.

The appeal is accordingly disposed of.

Notice of this decision be given free of cost to the parties.
