Briefly the facts in this appeal are that Ms. Meenakshi Jamwal D/o Sh. Ashok Jamwal R/o A/P H.No. 49, Sector 1, Channi Himmat, Tehsil & District Jammu-180015 moved an application dated 03-09-2013 under J&K RTI Act, 2009 before the PIO / Assistant Deputy Commissioner, Revenue Department, Jammu whereunder she sought certain information about the verification of genuineness/authenticity of the Permanent Resident Certificate issued in favour of Dr. Mridula Singh D/o Sh. Daleep Singh R/o 31-A, Bakshi Nagar, Jammu based on report of Tehsildar, Jammu vide his no. 1204 / HC, dated 05-01-1989 vide file no. 1203 PRC dated 09-01-1989.

In her counter reply AC(G), Jammu vide no. DCJ/LAA/327 dated 26-02-2014 submitted that applicant moved an application dated 12-03-2013 about the verification of the above said PRC and the information was furnished to the information seeker vide letter no. DCJ/PIO/RTI/2012-13/81 dated 22-04-2013. The PIO/AC(G), Jammu further submitted in the counter statement that she filed another application dated 06-09-2013 which was transferred U/S 6(3) to AC(G), Jammu for reply to the applicant and AC(G), Jammu responded vide letter no. DCJ/2013-

14/348 dated 24-09-2013. Subsequently the applicant preferred appeal before the FAA and also before the Commission and on the direction of the Commission reply obtained from Naib Tehsildar, Record Room, Jammu vide letter no. 210-211/NT/RTI/SRR dated 07-02-2014 was furnished to the applicant vide letter no. DCH/PIO/RTI/2012-13/1685.

It is clear from the aforesaid counter reply filed by the AC(G), Jammu that the information as available in office record has been furnished to the information seeker and as such no further direction in the matter is required.

The appeal is accordingly disposed of.
