Briefly the facts in this appeal are that the appellant moved an application dated 19-09-2013 before P.I.O SMVD University, Kakryal, Katra under Jammu and Kashmir Right to Information Act, 2009 whereunder he sought the following information:-

1. Copy of the Office Order extending the duration of the "six months" period [as specified in Ordinance 9(ii) governing Recruitment Procedure and Conditions of Services of University Employees] beyond the completion of inquiry proceedings and submission of Inquiry Report thereof (limited by Office Order No.SMVD/Adm/12/8126-30 dated 05-12-2012) by the Competent Authority, in respect of the u/s.

The appellant feeling aggrieved of inaction on part of the PIO as well as the First Appellate Authority filed second appeal dated 21-12-2013 before the Commission in which he has alleged that both the Registrar and PIO has given

their own views and irrelevant explanation to mislead and escape from providing the correct information sought. After receiving second appeal the matter was listed for hearing on 21-2-2014 at Jammu office of the Commission and the appellant was directed to clarify the information sought by him in the RTI application and submit the same in writing to the Commission before the next date of hearing. In compliance to the aforesaid direction of the Commission, the appellant vide his application dated 24-02-2014 clarified the nature of information required by him. The matter was again listed for hearing on 18-3-2014 and the RTI application of the information seeker was discussed threadbare. The appellant submitted before the Commission that he needs copy of the office order issued after 12-3-2013 extending the duration of six months period (as specified in Ordinance 9(ii) governing Recruitment Procedure and Conditions of Services of University Employees) beyond the time limit restricted by office order No.SMVD/Adm/Estt/12/8126-30 dated 05-12-2012.

Keeping in view the aforesaid facts and observations, PIO is hereby directed to clarify the duration of office order No.SMVD/Adm/Estt/12/8126-30 dated 05-12-2012. The PIO is further directed to specify whether any order in addition to the aforesaid order has been issued by the University in the case of the appellant. The aforesaid information may be provided to the information seeker within one week from receipt of this order under an intimation to the Commission.

The appeal is accordingly disposed of.

Notice of this decision be given free of cost to the parties.
