Briefly the facts in this complaint are that Sh. Abdul Haq S/o Salah Mohd. R/o Mehari Gujjrian, Tehsil & Distt. Rajouri moved an application dated 02-01-2013 before the Programme Officer, ICDS, Rajouri under the J&K Right to Information Act, 2009 whereunder he sought the following information:-

1. *Kindly provide the qualification particulars of selection order copies of below mentioned employees:-*
 - a. *Smt. Zahida Parveen W/o Mohd. Sadeeq R/o Pallulliom, Teh. & Distt. Rajouri and Photostat copies of Acquaintance Roll salary from the date of release in her name i.e. 2008 to 31-12-2012.*

Feeling aggrieved of inaction on the part of the PIO, the appellant knocked the doors of the Commission by filing a complaint dated 18-03-2013 before the Commission in which he has alleged that the PIO has not provided the requisite information within the statutory period. After receiving the complaint of the information seeker, the matter was listed for hearing on 26-02-2014. The PIO could not cause his appearance before the Commission as he was ill and has

produced the medical certificate dated 24-02-2014 duly issued by Dr. Zakir Hussain, M.S. Surgeon Specialist, District Rajouri whereas the complainant appeared before the Commission. The matter was again listed for hearing on 28-03-2014 at Jammu office of the Commission and both the parties were present.

During the course of proceedings, the PIO furnished a receipt duly signed by the complainant wherein he has acknowledged the receipt of the information on 15-02-2013. The PIO further submitted that a fresh set of information has again been submitted to the information seeker recently and copy of the same has been brought on record for reference. The complainant also acknowledged the receipt of the information duly provided by the APIO.

Thus, it is apparent from the aforesaid facts that the information sought by the information seeker stands already furnished to him and as such no further direction in the matter is required.

The complaint is accordingly disposed of.

Notice of this decision be given free of cost to the parties.
