Briefly the facts in this complaint are that Sh. Mehmood Ali Mir S/o Shokat Ali Mir R/o Village Lohil Bella, Tehsil Mandi, District Poonch moved an application dated 22-10-2012 before the PIO office of the Deputy Commissioner, Poonch seeking certain information relating to RET record.

The copy of the aforesaid application was also endorsed by the information seeker to Director School Education Jammu, Chief Education Officer, Poonch, Chief Education Officer, Jammu and Zonal Education Officer, Mandi for information and necessary action. Perusal of the record shows that PIO/Joint Director, O/o Director School Education Jammu transferred the application of the information seeker under section 6(3) of the RTI Act, to all the C.E.O's of Jammu province vide office letter No: DSEJ/RTI/4064-78 dated 01-12-2012 with the direction to provide the information to the information seeker within 5 days under an intimation to the Directorate. During the course of proceedings held today the Chief Education Officers, Samba, Rajouri and Ramban and PIO/ Chief Education Officer O/o Directorate of School Education Jammu informed the Commission that the information has already been furnished to the information seeker relating to query No. 8 of the RTI application Whereas the queries raised in Point No. 1-7 pertain to District Poonch and the information relating to Zone Mandi (Poonch) has also been furnished to the information seeker vide office letter No: 2100-2101 dated 13-03-2013. The aforesaid letter has been brought on the file for reference and record. The Chief Education Officer, Doda has also furnished the information to the information seeker and endorsed the copy to Director School Education Jammu vide office letter No:CEO/D/Monitor/30983-84 dated 13-12-2012. The perusal of the record shows that part of the information relating to District Poonch still remains to be furnished to the information seeker. The Chief Education Officer, Poonch is hereby directed to ensure that the information relating to query No. 1-7 is furnished to the information seeker within 10 days from the date of receipt of this order under an intimation to the Commission.

The complaint is accordingly disposed of.
