Briefly the facts in this complaint are that Sh. Kuldeep Raj R/o Village Dhalper, P.O Johnu, Tehsil and District Udhampur moved an application dated 10-01-2013 under J&K RTI Act, 2009 before the PIO / District Programme Officer, I.C.D.S, Udhampur seeking the following information:-

1. *Day by day attendance copies for the period w.e.f April, 2008 to December, 2012 (List of beneficiaries).*
2. *All the certificate copies of worker and helper enclosed at the time of appointment with application (alongwith residence proof).*
3. *Details of visits by supervisor at Anganwadi Cut Biomi for last four years.*
4. *Sanction/location order copy of the centre.*

Having received no response from the PIO within the statutory period, the information seeker approached the Commission by filing this complaint. The Commission vide its notice bearing no. SIC/J/C/08/2013/1257 dated 14-03-2013 directed the PIO O/o ICDS, Udhampur to send counter reply within 7 days of receipt of the notice and accordingly the PIO filed counter reply vide office letter no. POU/1310/2013 dated 04-04-2013. The PIO in counter reply submitted that the information has already been handed over to the information seeker under proper receipt by his office. The Commission issued hearing notice to the PIO as

well as the information seeker to appear before the Commission on 14th of May 2013 at 10.30 a.m.

During the course of proceedings held today, the PIO / District Programme Officer ICDS, Udhampur submitted a letter bearing no. POU/1501-1502/2013 dated 05-05-2013 wherein he has stated that the RTI application dated 23-08-2012 of the information seeker was forwarded to CDPO, Chennani and the information received from said office was handed over to the information seeker, but the applicant approached this office again and filed another RTI application dated 10-01-2013 and information sought from CDPO, Chennani was handed over to him under proper receipt on 06-03-2013 comprising 113 leaves. The PIO further submitted that the information required by the information seeker was furnished to him from time to time and there is no deliberate or intentional delay on his part in furnishing the information and whatever delay in there, it is circumstantial in nature as the information was to be collected and prepared by the field staff.

The information seeker was contacted telephonically and he informed the Commission that he has received the information as requested in his RTI application and is satisfied with the same. In view of the aforesaid submissions of the information seeker, no further direction in the matter is required.

The complaint is accordingly disposed of.

Notice of this decision be given free of cost to the parties.
