Briefly the facts in this complaint are that Gh. Ahmed Lone R/o Nowgam Marwah, Distt. Kishtwar moved an application dated 11-09-2012 under J&K RTI Act, 2009 before the PIO State Project Director, Sarva Shiksha Abhiyan, Jammu seeking the following information:-

- 1. How many EGs centres were opened in Zone Marwah? And how many EGs centre are upgraded to primary and middle school. Also give the name of EGs Centres?*
- 2. How many EGs employees were converted into RETs give their names, parentage and qualification, date of birth, order no. and date.*
- 3. How many primary and middle schools were constructed under SSA and RMSA? And how much funds were released for the above said construction. Give the names of the schools.*
- 4. How many bathrooms were constructed in 2009 to 2012 in the premises of school? And how much funds were released for these bathrooms.*

In his complaint before the Commission, the information seeker has alleged that the PIO (SSA), Jammu has failed to provide him the requisite information

within the prescribed time and has prayed that action as warranted under RTI Act, 2009 may be initiated against the State Project Director (SSA), Jammu and he may also be directed to furnish the information without further delay. The Commission after receiving the complaint issued notice bearing no. SIC/J/C/05/2013/1062 dated 04-03-2013 to the PIO and directed him to file counter statement in the matter before the Commission and in compliance to the aforesaid notice, PIO filed counter statement vide office letter no. Edu/SPD/SSA/907-IV/3229/13 dated 08-03-2013. The PIO has submitted in his counter reply that the RTI application of the information seeker was received in his office on 23-11-2012 and on the same date, application was marked to State Coordinator Access (SSA) and Executive Engineer (SSA) (dealing with requisite information) for necessary action / information compilation. The said RTI application was also communicated to CEO, Kishtwar and SPD RMSA vide no. Edu/SPD/SSA/907-III/12 dated 23-11-2012 (with copy for information to RTI applicant Mr. Gh. Ahmed Lone) accordingly depending upon the nature of information, as sought by the applicant. The PIO further submitted that CEO, Kishtwar and SPD RMSA, Jammu were also requested through same letter to provide the information, as sought, directly to information seeker under an intimation to the office of SSA.

During the course of proceedings, PIO submitted through video conferencing that the requisite information including final reply from CEO, Kishtwar, Executive Engineer (SSA) and State Coordinator Access(SSA) was received on 20-12-2012 and accordingly PIO, SSA replied / provided the information to the RTI applicant on 21-12-2012, vide office letter no. Edu/SPD/SSA/907-III/16264/12 dated 21-12-2012. The PIO apprised the Commission that no information as sought by the information seeker is pending in his office and whatever information was available in office record that was dispatched to the information seeker within the statutory period as envisaged in the J&K RTI Act, 2009. A critical analysis of the facts in this complaint enables the Commission to arrive at a conclusion that information as

sought by the information seeker already stands furnished to him and thus no further direction in the matter is required.

The complaint is accordingly dismissed.

Notice of this decision be given free of cost to the parties.
