Briefly the facts in this complaint are that Sh. Ch. Mandhi S/o Ch. Shaildin Gujjar R/o Vill. Bhalwal, Mohra Kangar, Tehsil and District Jammu moved an application dated 06-08-2012 under J&K Right to Information Act, 2009 before the PIO/ Deputy Superintendent of Police, District Jammu seeking the following information :-

1. Copy of statements of witnesses recorded by Sr. Superintendent of Police, Jammu Sh. Basant Kumar Rath in reference to Principal Secretary to Hon'ble Chief Justice, High Court of J&K Jammu's communication No. 351/PSy dated 5-12-2009 recorded in the month of December, 2009 in preliminary enquiry:-

 - b. Bikramjeet Singh SPO No:904/SPO
 - c. Puran Singh SPO No:69/SPO
 - d. Peer Mohd. S/o Hakum Din Gujjar R/o Kangar
 - e. Mir Hussain S/o Shukerdin R/o Kangar
 - f. Mir Hussain S/o Bulla R/o Kangar
 - g. Ayub Khan S/o Hamabdin R/o Dhar Dazochan.

- h. Azad Ali S/o Hakem Din R/o Kangar
- i. Sultan Ali S/o Bhag Ali R/o Dhar Darochan

The Commission after receiving the complaint of the information seeker issued notice bearing No:SIC/J/06/2013/1158 dated 11-03-2013 directing the PIO to send counter statement to the Commission within a weeks time. In compliance to the direction of the Commission, the PIO vide office letter No:RTI/2012/111/769 dated 19-03-2013 informed the Commission that complaint on behalf of complainant Ch. Mandhi under Right to Information Act, 2009 was received in their office through ZPHQ Jammu Zone vide No: Clt/192/J/Civ/PHQ/12/20600 dated 22-08-2012 and directed this office to furnish point wise reply to the ZPHQ Jammu at the earliest. That accordingly on receipt of this complaint a detail report into the matter was obtained from I/C Crime Section DPO Jammu and report obtained vide No. CRB/12/51 dated 09-08-2012 containing 24 leaves was submitted to ZPHQ Jammu vide office letter No:RTI/2012/108/2224-25 dated 24-08-2012. In compliance to the notice of the Commission, a copy of the same was also enclosed for the information of the Commission.

During the course of proceedings held on 12-04-2013, complainant submitted before the Commission that he may be provided certified copies of 24 leaves which has been send to the Commission as enclosures. In view of the aforesaid facts, the PIO is hereby directed to furnish certified photo copies of the aforesaid documents (statements of the witnesses) within 10 days from the date of receipt of this order under an intimation to the Commission.

The complaint is accordingly disposed of.
