

- d) Which is the authority which recognizes one year specialized course in Anesthesia was the requirement in terms of Advertisement Notice No. AHJ/2012/1941-45 dated 7th August, 2012 for appointment against the post of Anesthesia Assistants?
- e) Which is the authority which certifies the recognition of the institute from where the candidates are alleged to have done their one year specialized course in Anesthesia.
- f) Kindly supply the copies of the Diplomas in Medical Assistants of such of the candidates, who applied for appointment against the post of Anesthesia Assistants in pursuance to Advertisement Notice No. AHJ/2012/1941-45 dated 7th August, 2012 and whether such diplomas have been acquired by the candidates from recognized institute by the State Medical Faculty?
- g) Kindly supply the copy of the application received vide Receipt letter No. 5811 dated 29th August, 2012 in Government Medical College, Jammu Reception Section and whether the candidates in pursuance to the aforesaid applications had applied for appointment against the posts of ECG Technicians?
- h) Why the candidates, who applied in pursuance to RL No.5811 dated 29th August, 2012. Government Medical College Jammu Receipt Section had applied for appointment against the post of ECG Technicians in pursuance to Advertisement Notice No. AHJ/2012/1941-45 dated 7th August, 2012.
- i) What is the outcome of the selection process for the posts of Anesthesia Assistants, which was conducted in pursuance to Advertisement Notice No:DIP/J/4815 dated 19 July,2010 in terms of SRO 384 of 2009 dated 14th December, 2009 and for which the interviews were also conducted on 28th October, 2010 and only the said selection had not been finalized till date?
- j) Kindly provide the constitution of the Selection Committee/Interview Committee which conducted the interviews of the candidates for appointment against the posts of Anesthesia Assistants in pursuance to Advertisement Notice No. AHJ/2012/1941-45 dated 7th August, 2012 and whether any expert in Anesthesia was Member of the Interview

Committee/Selection Committee who conducted the interviews of the candidates for the selection to the posts of Anesthesia Assistants?

- k) Name the authority which had constituted the Selection Committee/Interview Committee for selection of candidates against the posts of Anesthesia Assistant in pursuance to Advertisement Notice No. AHJ/2012/1941-45 dated 7th August, 2012.

The information seeker feeling aggrieved of inaction on the part of the PIO as well as FAA moved the Commission by filing 2nd appeal dated 01-04-2013 in which he has alleged that no information till date have been provided to him. The matter was listed for hearing before the Commission on 08-05-2013. During the course of proceedings held on that day, a set of information comprising several pages was delivered to the information seeker by the PIO against proper receipt. Later on, the information seeker alleged that information provided to him only pertained to five candidates, whereas, information relating to seven candidates has not been furnished to him. The PIO agreed to furnish the rest of information and requested that information seeker be directed to collect it from his office on 09-05-2013. The matter was again listed for hearing on 30-05-2013. During the course of proceedings held today, the information seeker apprised the Commission that the PIO has not provided requisite information as sought by him in his RTI application and requested for furnishing the revised information.

Keeping in view the request of the information seeker, PIO is hereby directed to furnish the revised information to the information seeker within 10 days from the date of receipt of this Order under an intimation to the Commission.

The appeal is accordingly disposed of.
