Briefly the facts in this appeal are that Sh. Rashu Kanna R/o. H.No. 579, near Subhash Nagar P.O. Jammu moved an application dated 02-01-2013 under J&K Right to Information Act, 2009 before the PIO office of the Deputy Commissioner, Jammu seeking the following information:-

**Query No.1**

*Parentage of Uttam Singh, Ex-Corporator Ward No.38 Buta Nagar Paloura Jammu, Parentage of Karan Singh Parentage of Nirmal Sachar, having possession on land under Khasra No. 373 at Village Upper Thather, namely Karan Vihar Colony District & Tehsil Jammu, including Khewat. No., Mutation No. , date month and year of mutation.*

**Query No.2**

*Please specify Name. Parentage of Vendors of land who sold land to hereinabove persons under Kh. No. 373 & total land in possession of above*

*named persons at Village Upper Thather, namely Karan Vihar Colony District & Teh. Jammu.*

**Query No.3**

*Please specify Khasra Numbers, Khewat Numbers Mutation numbers, date, month and year of mutation, source of title i.e. Sale deed, Gift Deed, Lease Deed, or illegal possession to hereinabove persons at Village Upper Thather Karan Vihar Colony Teh. & Distt. Jammu.*

**Query No.4**

*Kindly supply the copies of the Sale Deeds and mutations on the basis of which hereinabove persons became owners of the land under Kh.No.373 at Village Upper Thather Karan Vihar Colony Teh. & District Jammu.*

**Query No.5**

*Please indicate separately how much land is proprietary and how much is state/khalsa/Shamilat-deh, Makbooza-Kalikan in Kh. No. 373 & how much is in illegal possession at Village Upper Thather, namely Karan Vihar colony District & Teh. & Jammu.*

**Query No.6**

*Please specify Name, Parentage of Colonizer developing a colony without obtaining Approval of layout plan from the competent authority i.e Building office Controlling authority of Jammu Development Authority established under J&K control of Building Operation Act. 1988 in Kh. No. 373, including Khewat No. and Mutation No. at Village Upper Thather Karan Vihar Colony Teh. & District Jammu & total land in possession.*

After receiving the application, the PIO transferred the same vide office letter no. DCJ/PIO/RTI/2013-14/3851-52 dated 22-01-2013 to Tehsildar, Jammu for further necessary action in the matter. The Tehsildar / PIO, Jammu vide office letter no. Teh/J/RTI/11-12/482 dated 07-02-2013 furnished the information to the information seeker. However, the information seeker was not satisfied with the information provided to him, he preferred appeal dated 04-02-2013 before the 1<sup>st</sup> Appellate Authority which remains sub-judice and has not been adjudicated and disposed of till date. The perusal of the documents on record shows that information as available in the office record was furnished to the information seeker.

During the course of proceedings held on 13-06-2013 the information seeker has alleged that the information provided to him is incomplete and incorrect and not as per his RTI application and he also expressed his desire to inspect the record. The Tehsildar / PIO, Jammu readily agreed to the request of information seeker for inspection of record and submitted before the Commission that the information seeker can access the record in his office on 17<sup>th</sup> of June 2013 during office hours.

In view of the aforesaid facts, the information seeker is directed to visit the office of Tehsildar / PIO, Jammu on 17-06-2013 and inspect the record. The PIO is directed to provide photocopies of the relevant documents free of cost to the information seeker in case the information seeker request for the same and also file compliance report to the Commission.

The appeal is accordingly disposed of.

Notice of this decision be given free of cost to the parties.
