Briefly the facts in this appeal are that Sh. Pritam Singh Saini, Editor, Daily Nawa-i-Waqat, Azeem English Paper, Lower Muthi, Akalpur Morh Chowk, P.O Udhewala, Tehsil and District, Jammu moved an application dated 21-12-2012 under J&K RTI Act, 2009 before the PIO O/o Municipal Commissioner, Jammu, Municipal Corporation, Town Hall, Jammu seeking certain information.

The information seeker was not satisfied with the information provided to him by PIO and preferred appeal dated 22-02-2013 before the FAA i.e Commissioner, Municipal Corporation, Jammu. The FAA vide his letter

No:MJ/Estt/9271-75 dated 02-03-2013 requested the appellant to remain present before the FAA on 9-03-2013 for hearing of the matter. During the course of hearing, the FAA advised the PIO to provide information to the appellant. The appellant has alleged in second appeal before the Commission that the information provided by the PIO was quite false, irrelevant, misleading and not in accordance with the request made under Form-1. The matter was listed for hearing before the Commission on 02-05-2013 and during the course of proceedings held on that day, the PIO assured the Commission that certified copies of the information shall be provided to the information seeker by tomorrow and the information seeker was advised to collect the same. The PIO also submitted before the Commission that some of the information sought by the information seeker was available with the Sr. Town Planner, Municipal Corporation, Jammu and he has been requested to provide the same. In view of the assurance given by the PIO, three week's time was granted for furnishing the rest of the information to the information seeker. The matter was again listed for hearing on 22-05-2013 and the information seeker requested that the PIO be directed to furnish complete and correct information to the information seeker and accordingly the direction was passed to the PIO to provide requisite information. The matter was adjourned and listed on 17-6-2013.

During the course of proceedings held today, the appellant has submitted application before the Commission mentioning therein that he has received rest of the information from the PIO on 13-06-2013 except the information relating to Plot No:503/3 which stands in the name of Sh. Sudershan Kumar S/o Sh. Kinu Ram at Channi Himmat, Jammu. The PIO agreed to furnish the information relating to said plot within week's time. In view of the aforesaid facts, the PIO is hereby directed to furnish the information relating to aforesaid plot to the information seeker within a week's time from the date of pronouncement of this order under an intimation to the Commission.

The appeal is accordingly disposed of.

Notice of this decision be given free of cost to the parties.
