Briefly the facts in this appeal are that Sh. Abdul Sattar S/o Sh. Wazir Mohammed R/o. H.No. 325-Sector-03-ext, Basant Vihar, Trikuta Nagar, Jammu moved an application dated 01-01-2013 under J&K Right to Information Act, 2009 before the PIO, Jammu Development Authority seeking certain information.

After receiving the application of the information seeker, the PIO, JDA vide office letter no. Secy/JDA/RTI/339/1019 dated 28-01-2013 furnished some information to the information seeker containing 4 leaves. Subsequently vide office letter no. Secy/JDA/RTI/339/1062 dated 04-02-2013 supplementary information was provided to the information seeker. The PIO, JDA again vide office letter no. Secy/JDA/RTI/339/1228 dated 08-03-2013 furnished the information relating to point no. 5-B and No. 6 of RTI application to the information seeker. However, the information seeker was not satisfied with the information provided to him and thus preferred

appeal dated 04-03-2013 before the 1st Appellate Authority. The FAA did not adjudicate and dispose of 1st appeal. Thus, feeling aggrieved of inaction on the part of the FAA, the information seeker preferred 2nd appeal dated 16-04-2013 before the Commission. After receiving 2nd appeal, the matter was listed for hearing before the Commission on 21-05-2013. During the course of proceedings held on that day the information seeker expressed his desire to inspect the record in the office of the Secretary, JDA. The PIO, JDA was directed to allow the information seeker an opportunity to inspect the record on 22-05-2013 at 11.00 a.m onwards. Accordingly, the PIO provided an opportunity to the information seeker to access the record in his office on the said date and time. The information seeker also informed the Commission telephonically that he has inspected the record and is satisfied with the information provided to him. The PIO also apprised the Commission that information seeker was allowed an opportunity to inspect the record in his office and was thus satisfied with the information provided to him. Thus, no further direction in the matter is required.

The appeal is accordingly disposed of.
