Briefly the facts in this appeal are that Sh. Mohammad Ayub Choudhery S/o Shri Roshan Din R/o Vill. Nadian, P.O Rakhison, Tehsil Darhal, District Rajouri moved an application dated 30-01-2013 under J&K RTI Act, 2009 before the PIO O/o Dy. Commissioner, District Rajouri seeking the following information:-

- (i) *About detail of Villagers of village Dangri, Tehsil and District Rajouri who were either killed or migrated to POK during the war of 1965, as per records of revenue with the District.*
- (ii) *About the immovable properties of Late Sheru Choudhery and Mohd. Hussain Both sons of Late Atta Mohd Choudhery Resident of Dangri, Tehsil and District Rajouri.*
- (iii) *About if Late Sheru Choudhery and Mohd Hussain Choudhery both sons of Late Atta Mohd Choudhery (above)*

were killed during 1965 War, as per the records with Revenue Department of Rajouri.

- (iv) About if the immovable properties left behind by the Late Sheru Choudhary and Mohd. Hussain Choudhary (above) is controlled and under possession of Govt. or Evacuee Property Department. Provide the details of the properties.*
- (v) About legal heirs of Late Sheru Choudhary and Mohd Hussain Choudhery (above), provide the details of the heirs inn Revenue Records of Dangri, Teh. Rajouri.*

During the course of hearing, PIO informed the Commission that information as requested by the information seeker in his RTI application has been furnished to him. However, the information seeker has alleged that information provided by the PIO is incomplete and incorrect, whereas PIO has vehemently denied the same and submitted before the Commission that information furnished to the information seeker was as available in the Revenue record maintained by the Department.

Keeping in view the submissions of the information seeker and in order to ensure his satisfaction, it would be apt to allow him an opportunity to access the record in the office of PIO, so that the information if available in the office record should be furnished to him. The PIO is hereby directed to allow an opportunity to the information seeker to inspect the revenue record in his office on 8th of July, 2013 at 10.a.m and in case the information seeker requests the copies of any relevant document that may be provided to him free of cost. The PIO is further directed to file compliance report to the Commission.

The appeal is accordingly disposed of.

Notice of this decision be given free of cost to the parties.
