Briefly the facts in this appeal are that S. Gurmukh Singh S/o Late S. Tara Singh R/o Vill. Deep Nagar, Kunjwani, Jammu moved an application dated 12-02-2013 under J&K RTI Act, 2009 before the PIO, Custodian General, Evacuee Property, Wazarat Road, Jammu seeking the following information :-

- i. Issue attested copy of Form 'A' and register cancellation of Gurmukh Singh Allottee of Rakh Lachhi Pura, Tehsil Kathua and

copy of register cancellation of Gurbaksh Singh son of Tara Singh allottee of Chak Ramchand, Kathua.

As per your letter No. PRO/2012-13/48-5 dated 9-11-2012 addressed to the Dy. Commissioner, Kathua.

ii. About attested copy of Form-A above for 4 members 48 Kanals of land was allotted at Chak Ramchand. But for settlement of Basti at time 22K-10 Marla of land was taken back out of 43 Kanals at Chak Ramchand, Kathua, on the pretext that Sardar Gurmukh Singh will be allotted double of the land at Lachhipura, Kathua out of the allotted land at Chack Ramchand, Kathua, as per the order passed by the then Dy. Commissioner, Kathua (S. Sohan Singh).

On the orders of then D.C Kathua, 44 Kanals- 1 Marla stands allotted at Lachhi Pura, Kathua to Sardar Gurmukh singh (allottee).

The information seeker did not receive any information from the PIO within statutory period. Thus feeling aggrieved, he preferred appeal dated 15-03-2013 before the FAA i.e Custodian General, Evacuee Property, Jammu. Copy of the appeal was endorsed to Dy. Custodian Kathua. Perusal of the record shows that Ist appeal has not been adjudicated and disposed of till date. Thus, feeling aggrieved of inaction on the part of the PIO as well as FAA, appellant approached the Commission by filing second appeal dated 13-05-2013. During the course of proceeding held today, PIO informed the Commission that partial information has been provided to the information seeker as per office record. In view of the aforesaid facts, PIO is hereby directed to furnish revised information to the information seeker as per office record if already not provided , within 10 days from the date of pronouncement of this order under an intimation to the Commission.

The appeal is accordingly disposed of.
