Briefly the facts in this appeal are that Smt. Rani Devi D/o Late Sh. Gouri Lal R/o Army Gate, Bye pass Road, Channi Rama, Jammu moved an application dated 19-02-2013 under J&K RTI Act, 2009 before the PIO, Sr. Superintendent of Police, Jammu seeking certain information.

The PIO vide office letter No.RTI/2013/28/606-07 dated 08-03-2013 furnished information to the information seeker comprising of 03 leaves against proper acknowledgement. The information so furnished to the information seeker contained the report of Dy. Superintendent of Police, SDPO City East, Jammu addressed to Superintendent of Police, City South, Jammu vide office letter No. 2286/SDCEJ dated 28-02-2013 and point wise reply received from SHO, Police Station, Channi Himmat Jammu.

Perusal of the record shows that information as requested by the information seeker and available in the office record has been furnished to her within statutory period. However, during the course of proceedings, the information seeker alleged that under which authority erstwhile SHO, Police Station Channi Himmat, Jammu Shashi Thakur alongwith Fateh Ali and other elements entered and bulldozed her house in order to evict her and her family from the above said land and why FIR has not been lodged against the culprits till date by the Police authorities. The information seeker wants registration of FIR against the alleged culprits which does not fall within the domain of the Commission and thus no direction in this regard can be issued. However, the information seeker is advised to approach the proper forum for redressal of her grievances. The information as available in the office record stands already furnished to her and thus no further direction in the matter is required.

The appeal is accordingly disposed of.
