Briefly the facts in this appeal are that Sh. Talib Singh S/o Late Sh. Jagat Singh R/o Mandi Gurgalian , P.O Samba Tehsil and District Samba moved an application dated 08-02-2012 under J&K RTI Act, 2009 before the PIO, Commissioner/Secretary of J&K Govt., Department of Revenue, Civil Secretariat, Srinagar seeking the following information:-

- **1.** A remand case was retained in the office of Financial Commissioner (Revenue) more than 10 years. Now the case sent to Jt. Finance Commissioner Jammu. The said case will be again retained more than 10 years in the office of the Jt. Commissioner in future. If so please inform accordingly.
- **2.** Kindly watch officers under command. I presume the initiator of Annexure B is not skillfull officer because he is not taking responsibility at his ownand to say creating great trouble to his superior officers. Kindly inform your kind view in this regard.

- **3.** Whether he case will also take more than 10 years, if so please inform accordingly.
- **4.** Kindly your kind attention is also invited on annexyre D.E.F. H a long awaiting case of land merged in Railway during 1971 and not provided compensation till date .

Sh. Talib Singh has filed second appeal before this Commission against the order of FAA /Dy. Commissioner, Central Office of Financial Commissioner, Revenue J&K Jammu. The RTI application of the information seeker was disposed of by PIO/Administrative Officer, financial Commissioner Revenue, J&K on 09-03-2012. Perusal of the RTI application of the information seeker clearly shows that he is aggrieved of the delay caused in administrative action regarding certain matters pertaining to him pending before Financial Commissioner (Revenue) J&K. The queries raised by the information seeker are not covered under the definition of information as provided under section 2(d) of J&K RTI Act, 2009. The RTI application of the information seeker has been rightly responded by the PIO. Perusal of the order passed by the FAA shows that it does not suffer from any illegality and has been rightly passed and is upheld. The second appeal filed by the information seeker is hereby dismissed being devoid of merit.

Notice of this decision be given free of cost to the parties.
