Briefly the facts in this appeal are that Sh. Manmohan Singh S/o Sh. Bhagat Singh R/o 71, Shastri Nagar, Jammu moved an application dated 03-12-2012 under J&K RTI Act, 2009 before the PIO, J&K Board of School Education, Rehari Colony, Jammu seeking the following information :-

- 1. Furnish me the copy of covering letter of Indian Institute of Psycometry attached with the result of Junior Assistants submitted to JK BOSE.*

The PIO vide office letter No:F(Info-Cell)JD/B/2013 dated 02-07-2013 intimated the Commission that information that was existing and made available to her by the concerned section has been provided to the appellant vide office letter No:F(Info-Cell)JD/JD/12/391 dated 13-12-2012. She further informed that for redressal of his grievances the appellant was provided three opportunities for personal hearing before the

FAA on 16-02-2013, 26-02-2013 and 24-05-2013 respectively. But on all the three occasions the appellant did not turn up for hearing. However, during the course of proceedings, appellant submitted before the Commission that he was out of State and thus could not attend hearing before the FAA and requested that he may be furnished the photo copy of covering letter of Indian Institute of Psycometry attached with the result of Junior Assistants submitted to JK BOSE. However, PIO informed the Commission that no covering letter of Indian Institute of Psycometry was submitted alongwith the result of Jr. Assistants in order to maintain the confidentiality of the agency which conducted the examination of Jr. Assistants.

In view of her submissions, it is apparent that no such covering letter is available and thus information as sought by the information seeker cannot be provided to him. No further direction in the matter is required.

The appeal is accordingly disposed of.
