Briefly the facts in this appeal are that Sh. Manmohan Singh S/o Sh. Bhagat Singh R/o 71, Shastri Nagar, Jammu moved an application dated 24-11-2012 under J&K RTI Act, 2009 before the PIO, J&K Board of School Education, Rehari Colony, Jammu seeking the following information :-

Funds Details Received from State and Centre Government.

- 1. Furnish me the details of the Heads and Funds allotted for utilization to the JKBOSE for the year 2008-09, 2009-10, 2010-11, 2011-2012, 2012-2013.*
- 2. Whether all the funds were utilized before 31st March or not.*
- 3. The details of the expenditure of the funds during the period 2008-2009, 2009-10, 2010-11, 2011-12, 2012-13 will be provided to me.*
- 4. Copy of the utilization certificate submitted by the Board to Centre and State Govt. as on 31st March be furnished.*

5. *In case the funds could not be utilized then the details of amount of the funds returned to centre and state along with date when the amount was returned.*
6. *In case there is gap of some period after 31st March till date of returning the balance amount in full to the centre and state government then where the amount was kept. Details may furnished and along with the interest accrued thereon in case it was deposited in Bank.*
7. *If the amount stood deposited in bank after 31st March then who received the interest accrued thereon from the bank.*

The PIO vide office letter No.F9Info-Cell)JD/B/2013 dated 02-07-2013 informed the Commission that information as received from the concerned section has already been provided vide office letter No:F(Infor-Cell)7D/B/2012/381 dated14-12-12. However, during the course of proceedings information seeker stressed that he has not been provided information relating to details of Heads through which accounts are being operated by J&K BOSE. The PIO agreed to furnish the same after collecting it from the concerned section and sought two weeks time.

In view of the aforesaid facts, PIO is directed to provide the requisite information relating to various Heads through which accounts are operated by J&KBOSE within two weeks from the date of receipt of this order under an intimation to the Commission.

The appeal is accordingly disposed of.

Notice of this decision be given free of cost to the parties.
