Briefly the facts in this appeal are that Sh. Mohd. Sadiq R/o C-3, Village Enclave, East Extension 1/C, Trikuta Nagar, Jammu moved an application on 30-03-2013 before the PIO Superintending Engineer, EM & RE Circle-1, Panama Chowk, Jammu seeking the information relating to details of load and electricity connection provided to Satyam Resort, JK Plaza, JK Resort and JK Channel Office situated at village Deeli, near Marble Market, Jammu. The information seeker also sought photo copy of documents submitted

by the aforesaid consumers while seeking electricity connection of their premises. The information was furnished to the information seeker by Executive Engineer, EM&RE Division-II, Gandhi Nager Jammu vide No;EMD-II/10-13 dated 09-04-2013. However, the information seeker was not satisfied with the information provided to him and moved the Commission by filing second appeal in which he has alleged that information is incomplete and not in conformity with his RTI application.

Perusal of record shows that the information provided to the information seeker is incomplete in nature and the information seeker has not been provided photo copies of documents on the basis of which connections were issued in favour of the aforesaid consumers. In view of the given facts, PIO / Executive Engineer, EM&RE Division-II, Gandhi Nager Jammu is hereby directed to furnish revised information as requested by the information seeker in his RTI application within one week from the date of pronouncement of this order under an intimation to the Commission.

The appeal is accordingly disposed of.

Notice of this decision be given free of cost to the parties.
