## <u>Jammu</u> 12-07-2013

Briefly the facts in this appeal are that Sh. J.N Wadhera R/o 494-A, Jullaka Mohalla, Jammu moved an application dated 06-11-2012 under J&K Right to Information Act, 2009 before the PIO O/o Cantonment Board Jammu, for seeking the following information:-

- 1. How many G+2 Buildings have been existing in Jammu Cantt. Area with breakup of Private and Govt. Buildings.
- 2. When the rule for G+2 building was passed by the Cantt. Board, Jammu. Please provide a copy of the Board resolution.
- 3. How many encroachments/buildings have been compounded for the last 5 years with break up of residential and commercial buildings with names and location of defaulter.
- 4. What is the total amount of compounding fee recovered for the

- 5. last 5 years and what rate of compounding fee was charged. Please provide a list of the defaulters with money recovered.
- 6. How much house/building tax has been recovered in the last 5 Years. Please give year wise detail 2007-08, 2008-09, 2009-10, 2010-11 and 2011-12.

The CPIO/ O/o Chief Executive Officer, Jammu Cantt. furnished information to the information seeker vide office letter No: CBJ/RIA/2013-14/230 dated 21-06-2013. The CPIO O/o CEO, Jammu Cantt. in his counter statement before the Commission submitted that the information could not be delivered to the information seeker in time due to involvement of concerned officials in regular court cases as well as Sh. Rakesh Sharma, Jr. Engineer of Cantonment Board, Jammu proceeded on leave for the reason of sickness of his father who suffered with heart ailment and was admitted in Govt. Medical College, Jammu. Though there is delay on the part of the CPIO in furnishing the information to the information seeker but he has explained the same and does not speak of any malafide on his part and delay is not intentional but circumstantial. The requisite information as sought by the information seeker stands already furnished to him. Thus no further direction in the matter is required.

The appeal is accordingly disposed of.

Notice of this decision be given free of cost to the parties.
