The Commission vide its decision No:SIC/J/A/164/2012/356 dated 22-10-2012 directed the PIO/Custodian, Evacuee Property, Jammu to furnish the information to the information seeker, free of cost, within two weeks from the date of pronouncement of this order under an intimation to the Commission. The information seeker Sh. Raj Kumar S/o Sh. Anant Ram R/o 127/9 Keran Gurah, Bantalab, Jammu filed an application dated 7-11-2012 before the the Commission alleging therein non-compliance of the aforesaid order. After receiving the complaint for non-compliance, notice was sent to the PIO/ Custodian, Evacuee Property, Jammu who vide letter No: 835/AP dated 26-11-2012 informed the Commission that details of Khasra Nos. received from Assistant Custodian (Tehsildar) R.S. Pura stands already furnished to the information seeker as per the directions of the Commission. PIO further informed the Commission that Custodian's office receives the rent in lumpsum from Director, Agriculture in respect of

the Chakroi Farm at R.S Pura yearly in pursuance of notification issued by the Government as per the classification of the land. He has also submitted vide above letter that Custodian Department does not know as to whether the personal land of the information seeker is involved in the Farm or not.

However, during the course of proceedings held today, the information seeker alleged that he has not been provided para-wise reply of his RTI application. In view of the submissions made by the information seeker, PIO is hereby directed to furnish para-wise reply revised information to the information seeker as sought by him in his RTI application within 15 days from the date of receipt of this order under an intimation to the Commission.

The complaint for non-compliance is accordingly disposed of.

Notice of this decision be given free of cost to the parties.
