Briefly the facts in this appeal are that Sh. Raj Kumar S/o Sh. Anant Ram R/o 127/9 Keran Gurah, Bantalab, Jammu moved an application dated 02-04-2013 under J&K RTI Act, 2009 before the PIO/Chief Engineer, PHE Rural Division, Jammu seeking certain information relating to Permanent/ Daily wagers/employees in Marh Block of PHE Department.

The PIO/Executive Engineer, PHE Rural Division Jammu furnished the information to the information seeker vide office letter No: PHER/1044-46 Dated 02-05-2013. The information so provided to the information seeker related to officers and workers engaged on permanent basis in PHE Rural Sub-Division Marh Block. However, the information seeker was not satisfied with the information provided to him. Feeling aggrieved of the order of the PIO, the information seeker preferred Ist appeal dated 02-05-2013 before the Chief Engineer, PHE Division, Jammu. After availing the facility of Ist appeal, the information seeker approached the Commission by filing second appeal dated 04-06-2013 alleging therein that he has not received requisite information as requested in his RTI application. Accordingly, the notices were sent to the PIO/Executive Engineer, PHE Rural Division Jammu and the appellant to remain present before the Commission on

22-07-2013. In response to the Commission's notice, PIO appeared before the Commission and apprised that information as requested by the information seeker was sent to him vide office letter NO: PHER/1044-46 Dated 02-05-2013 and another set of information was furnished vide office letter No:290/K-1 dated 8-06-2013. The PIO/ Executive Engineer, PHE Rural Division also informed the Commission vide letter NO:PHER/2793-94 dated 29-06-2013 that the information as sought by the information seeker was furnished to him and copy of reply was also endorsed to the Commission for reference and record. However, perusal of information so provided to the information seeker shows that the information relating to query No. 3 and 4 has not been properly answered and in this context, it is hereby ordered that revised information relating to query No. 3-4 be furnished to the information seeker within one week from the date of receipt of this order under an intimation to the Commission.

The appeal is accordingly disposed of.

Notice of this decision be given free of cost to the parties.
