Briefly the facts in this appeal are that Sh. Kiker Singh S/o Sh. Shiv Ram, President Sudhar Sabha Committee, Hartaryan Udhampur moved an application dated 29-01-2013 under J&K RTI Act, 2009 before the PIO/ Addl. Dy. Commissioner, Udhampur seeking certain information.

In his second appeal before the Commission, the information seeker alleged that the PIO did not furnish the requisite information and he submitted Ist appeal to the Divisional Commissioner, Jammu which was transferred to Dy. Commissioner, Udhampur. Perusal of record shows that the Dy. Commissioner, Udhampur has not adjudicated and disposed of Ist appeal till date. After receiving the second appeal, notices were sent to the parties and matter was listed for hearing through video conferencing on 25-07-2013 and both the parties were present. Sh. Surat Singh, Addl. Dy. Commissioner, Udhampur/PIO apprised the Commission that partly the information has already been furnished to the information seeker and information seeker also acknowledged the receipt of the same. The PIO further apprised the Commission that rest of the information being

voluminous and needs to be compiled and collated after perusing the office record and in this regard necessary instructions have been issued to the field staff to prepare the same. The PIO assured the Commission that the said information will be furnished to the information seeker within 7days. The information seeker also expressed his satisfaction over the information provided to him and cooperation solicited offered by the Revenue Authorities in this regard.

In view of the aforesaid facts, PIO is directed to adhere to the undertaking given to the Commission for furnishing information to the information seeker within 7 days from the date of pronouncement of this order and file compliance report to the Commission.

The appeal is accordingly disposed of.

Notice of this decision be given free of cost to the parties.
