Briefly the facts in this complaint are that Sh. Mohd. Farooq and other people of Mohra Zairat Amlimitti R/o Plangarh P/H 23A P/o Behrote Tehsil Thanna Mandi (Rajouri) moved an application dated Nil under J&K RTI Act, 2009 before the PIO /Executive Engineer, Electric Project Division, RGGVY, Rajouri-Poonch seeking the following information :-

i. Subject matter of information:-

1. Demand of Rs, 10,000/- as corruption for the adjustment of 25 kv transformer sanctioned in 2005 for Mohra Zairat Amlimitti (Plangarh)
2. Why the said transformer was not adjusted on sanctioned point till date.
3. Wrong adjustment of Poles in another place i.e Mohra Plangarh on corruption basis 2005 to 2013

ii. Description of information required

- vii. Transformer of 25 kv of Mohra zairat Amlimitti Plangarh.
- viii. Total number of poles of the said transformer.
- ix. Other material of the station above mentioned.

The PIO /Executive Engineer, Electric Project Division, RGGVY, Rajouri-Poonch vide office letter No:EPD/RGGVY/RP/175 dated 18-05-2013 filed counter statement before the Commission in which he has given point wise reply to the queries raised by the information seekers in their RTI application. The copy of the information as desired by the information seekers is also enclosed with the counter statement as Annexure 1. The complainants in their complaint dated 25-03-2013 prayed before the Commission that PIO be directed to provide the requisite information and also leveled allegations of corruption and wrong adjustment of poles and non-adjustment of 25 Kv transformer sanctioned for Mohra Zairat Amlimitti Plangarh against the department of RGGVY Rajouri-Poonch.

Perusal of the complaint filed by the complainants shows that it raises allegations of corruption and failure to perform duties by the officials of the department of RGGVY Rajouri-Poonch which is not subject matter of information and does not fall within the scope of RTI Act, 2009. The complainants are advised to approach the appropriate forum for redressal of their grievance relating to corruption and non-performance of duties by the officials of RGGVY Department Rajouri-Poonch. Keeping in view the request of the complainants, the PIO /Executive Engineer, Electric Project Division, RGGVY, Rajouri-Poonch is hereby directed that what he has submitted in the counter statement in the form of information may be furnished free of cost to the information seeker within two weeks from the date of receipt of this order under an intimation to the Commission.

The complaint is accordingly disposed of.

Notice of this decision be given free of cost to the parties.
