Briefly the facts in this complaint are that Sh. Sewa Ram (Sarpanch Tagood) Panchayat Tagood R/o Village Tagood, Kishtwar moved an application dated 10-01-2013 under J&K RTI Act, 2009 before the PIO Assistant Executive Engineer, Irrigation and Flood Control, Sub-Division Kishtwar seeking certain information.

The information was not sought from the PIO/Executive Engineer, Hydraulic Division, Kishtwar. The FAA i.e Superintending Engineer, Hydraulic Circle, Doda vide his communication NO:SED/H/1140-41 dated 13-06-2013 intimated the Executive Engineer, Hydraulic Division, Kishtwar regarding supply of information. The Executive Engineer, Hydraulic Division, Kishtwar accordingly vide office letter No:HDK/1599-1600 dated 26-06-2013 requested the Executive Engineer, I&FC Division Baderwah

to make available the relevant record to the appellant. The appellant vide letter No: nil dated 25-07-2013 informed the Commission that Asstt. Executive Engineer, I&FC, Sub-Division, Kishtwar has shown him the office record and he is satisfied with the information provided to him and requested that his complaint may be treated as closed. The PIO has also filed an affidavit dated 27-07-2013 duly attested by Public Notary in support of his counter statement and stating therein that the information seeker was shown relevant record and he has inspected the same.

In view of the aforesaid facts and as requested by the information seeker for closure of his complaint, it is hereby ordered that information as sought by the information seeker stands already furnished to him and he also expressed his satisfaction about the same. Thus, no further direction in the matter is required.

The complaint is accordingly disposed of.
