Briefly the facts in this appeal are that Sh. Nirmal Singh & Others R/o H. No.39/3 Ganga Nagar, Ban Talab, Jammu moved an application dated 23-8-2012 under the J&K RTI Act, 2009 before the PIO/ Assistant Commissioner Revenue, Jammu seeking certain information relating to yearly rental compensation for land requisitioned by the Army belonging to the owners of village Makwal, Tordala, Mahthin and Kanalayn.

The PIO/Asstt. Commissioner Revenue Jammu vide office letter No:DCJ/PIO/RTI/2012-13/2588 dated 15-09-2012 furnished the information to the information seeker. However, the information seeker has alleged in Ist appeal before FAA as well as second appeal before the Commission that the information provided to him was incomplete and incorrect. He has also alleged manipulation of records for swindling the rental compensation of village Makwal (Jindrah) Tehsil and District Jammu. Perusal of the documents available on record show that the PIO has furnished the information to the information seeker which was available

in the office record. However, the information seeker is not satisfied with the information provided to him and requested the Commission that he may be allowed an opportunity to access the record in the office of PIO. The PIO readily agreed to the request of the information seeker and apprised the Commission that information seeker is at liberty to access the record in his office on any working day.

Keeping in view the request of the information seeker and assurance given by the PIO, it is hereby ordered that the information seeker may be provided an opportunity to access the record in the office of Asstt. Commissioner Revenue, Jammu on 16-08-2013 during the office hours. The PIO is further directed to issue certified copies of relevant record free of cost if any required by the information seeker and file compliance report to the Commission.

The appeal is accordingly disposed of.

Notice of this decision be given free of cost to the parties.
