Briefly the facts in this appeal are that Sh. Naresh Gupta R/o 140, Mohalla Paharian, Jammu moved an application dated 09-02-2013 under J&K RTI Act, 2009 before the PIO O/o Municipal Commissioner, Jammu Municipal Corporation, Town Hall, Jammu seeking the following information :-

1. That please provide the copies of Building permissions alongwith Maps and Land documents of three storied commercial complexes of R.M Traders, wholesaler of shoes and Khairati Traders wholesaler of readymade Garments Mohalla Paharian, Jammu.
2. That whether the Jammu Municipal Corporation has provided these permissions for Residential or commercial purpose.
3. That if these permissions/constructions are illegal what action has been taken against these buildings so far.
4. That please provide us the copies of Maps and Permissions as well as Land documents of all the buildings of Mohalla Paharian those have obtained the building permissions for commercial purposes till date.

The Senior Town Planner, Municipal Corporation Jammu/PIO furnished the information to the information seeker vide office letter No:75-76/BS/2012 dated 30-03-2013. However, the information seeker was not satisfied with the information provided to him and preferred Ist appeal dated 2-05-2013 before the First Appellate Authority, Municipal Commissioner, Jammu. The information seeker did not receive any reply from the FAA and during the course of proceedings, the PIO also informed the Commission that the first appeal has not been adjudicated and disposed of till date. Thus feeling aggrieved the information seeker preferred second appeal before the Commission alleging therein that the information relating to queries No.1 and 3 is incomplete and incorrect and prayed that PIO be directed to provide complete information.

During the course of proceedings held today, the PIO agreed to furnish the revised information relating to query No. 1 and 3 of the RTI application of the information seeker and requested that he may be given a week's time to furnish the same. Keeping in view the aforesaid facts, it is hereby ordered that the revised information pertaining to query No. 1 and 3 of the RTI application of the information seeker as available in office record shall be provided to him within 7 working days from the date of receipt of this order under an intimation to the Commission.

The appeal is accordingly disposed of.

Notice of this decision be given free of cost to the parties.
