Briefly the facts in this appeal are that Sh. Kovid Khosla, Advocate, J&K High Court Jammu, Opposite Eicher Showroom, Main Road, Sidhra, Jammu moved an application dated 25-04-2013 under the J&K RTI Act, 2009 before the PIO O/o Dy. Director CA&PD, Nandani Hills, Samba seeking the following information:-

- A. Documents including D-Form on the basis of which ration Book No.420742 (Reg. No-92) has been issued in favour of Krishno Devi w/o Sh. Mani Ram R/o Kalwal, Tehsil and District Samba.
- B. Whether the ration book mentioned above still exists or has been cancelled, if yes, then provide the details and grounds on which the same stands cancelled supported with the proof of same including the date of cancellation.
- C. Copy of the application for cancellation of ration card made by the applicant if any be also provided.
- D. Monthly Details of the ration issued since 2010 to the above named ration card holder on above ration card book till date or till date of its cancellation.

The PIO in his counter reply filed before the Commission vide office letter No:ADCAPD/S/2013-14/300-01 dated 01-08-2013 submitted that application dated 25-04-2013 was received through Assistant Commissioner Revenue, Samba under No:DCS/HQA/RTI/2013-14/130-131 dated 10-05-2013 which was forwarded to Tehsil Supply Officer, Samba/APIO vide office letter No:

ADCAPD/s/2013-14/130 dated 15-05-2013 for furnishing the requisite reply in the matter. After receipt of requisite information from the office of TSO,CA&PD Samba/APIO, under NO: TSO/S/13-14/103-04 dated 14-06-2013 the same was furnished to the information seeker vide office letter No:ADCAPD/S/2013-14/206-08 dated 14-06-2013 by ordinary post. However, during the course of proceedings, the information seeker alleged that information provided to him was incomplete and incorrect and was not as per his RTI application and requested that PIO be directed to provide him the revised information.

Perusal of the information provided to the information seeker also shows that information is incomplete in nature and needs to be revised . Keeping in view the aforesaid observations, the PIO is hereby directed to provide the revised information to the information seeker free of cost within 10 working days from the date of receipt of this order under an intimation to the Commission. The PIO is further directed to send the information to the information seeker under a registered cover.

The appeal is accordingly disposed of.

Notice of this decision be given free of cost to the parties.
