Briefly the facts in this appeal are that Sh. Balwinder Singh Pawar R/o V.P.O. Gandharwan Tehsil Akhnoor, Distirct Jammu moved an application dated 18-02-2013 under J&K RTI Act, 2009 before the PIO / BDO Bhalwal, J&K Rural Development Department seeking the following information:-

- 1. Details relating to the developments constructed works done under various schemes (i.e. MGNREGA, CDF, BADP, IAY, SCA, Health etc.) during 2009-10 and 2010-11 sessions of Block Bhalwal of District Jammu (J&K) Panchayat wise separately.*
- 2. Give details that how much financial assistance have been sanctioned by the government for development work to be done under various panchayats of block Bhalwal including certified copies of the bills and vouchers showing the details of expenditure incurred by the department on various developmental works particularly 'MGNREGA' for the above said financial years.*
- 3. Give the photostat certified copies of bills and vouchers regarding expenditure incurred (in Rs.) of various schemes only in respect of Panchayats namely Amb, Bhalwal, Gharota, Malpur, Raipur, Ranjan, Patoli-Brahmana, Doomi and Dhanu Sarote.*

4. *Only copies of bills and vouchers are required which actually shows the expenditure(in Rs.) and not in supporting or necessary documents annexured with the file as a routine work and on the basis of which grant has been withdrawn from the govt. exchequer.*

During the course of proceedings held today, the PIO informed the Commission that the information was sent to the information seeker through speed post. The information seeker also acknowledged the receipt of the same. However, the information seeker alleged that the photocopies of certain documents have not been certified by the office of the BDO, Bhalwal and information provided to him is also incomplete in nature.

In view of the request of the information seeker, the PIO is hereby directed to attest the photocopies of the information already provided and also allow him an opportunity to inspect the record in his office on 17th of September, 2013 during working hours and provide photocopies of relevant documents if any required by the information seeker. The PIO is also directed to file compliance report to the Commission.

The appeal is accordingly disposed of.

Notice of this decision be given free of cost to the parties.
