Briefly the facts in this complaint are that Mrs. Nisha Kundal W/o Sh. Parveen Jangwal R/o Khandwal, P/o Simble Camp, Tehsil and District Jammu moved an application dated 03-04-2013 under the J&K RTI Act, 2009 before the PIO, office of the Director, Rural Development Department, J&K Govt. Gramin Vikas Bhawan, Talab Tillo, Jammu seeking information relating to *action taken report with respect of her representation dated 26-02-2013 filed before the Director, Rural Development Department, J&K Govt. Gramin Vikas Bhawan, Talab Tillo Jammu.*

In the aforesaid representation, Mrs. Nisha Kundal has challenged the appointment of Smt. Sapna Rani as Gram Rozgar Sewak on contractual basis under MGNREGA scheme and requested for cancellation her engagement as Gram Rozgar Sewak for village Panchayat Halqa Khandwal, Block Satwari, Jammu. The PIO furnished the entire information including the photocopies of documents submitted by Smt. Sapna Rani W/o Sh. Viney Raj for appointment as Gram Rozgar Sewak on contractual basis under MGNREGA. However, the

information seeker was not satisfied with the information provided to her. She filed an appeal dated 30-01-2013 against PIO, (ACD Jammu) under J&K RTI Act, 2009. The FAA disposed of the appeal vide order NO:DRDJ/RTI-205/21876-78 dated 21-02-2013 with the observation that the appellant stated that she has already received the requisite information through Registered post and has no further grievance. The FAA did not deliberate on action taken report with respect to her representation dated 26-02-2013 filed before the Director, Rural Development Department Jammu. Thus, it is evident from the aforesaid facts that the information which has been sought by the information seeker has not been furnished to her. The PIO is hereby directed to provide her information about the action taken report on her representation dated 26-02-2013 filed before the Director, Rural Development Department, Jammu within 10 working days from the date of receipt of this order under an intimation to the Commission.

The complaint is accordingly disposed of.

Notice of this decision be given free of cost to the parties.
