Briefly the facts in this appeal are that Sh. Baldev Raj S/o Sh. Thoru Ram R/o Village Salehar, Teh. R.S. Pura, Distt. Jammu, moved an application dated 08-01-2013 under J&K Right to Information Act, 2009 before the PIO O/o Jammu Development Authority, Jammu, seeking the following information:-

- 1. Whether plan of dismantled (dismantled)shops has been provided to Public Works Department, Jammu as required by them?*
- 2. If so, whether required amount of compensation stands paid to JDA by PWD and whether the same has further been paid to concerned allottees.*

The PIO / Secretary, JDA, Jammu informed the information seeker vide office letter no. Secy/JDA/RTI/359/298-300 dated 04-09-2013 that as per record, the detail estimate for dismantling of 10 Nos. shops at New Bahu Fort Colony coming under alignment of new road connecting IInd bridge was sent to Executive Engineer, PWD Div. No. IV for payment of compensation. The PWD has accordingly furnished the compensation cheque of Rs. 2.07 lacs. The JDA has returned the cheque with the plea that this is insufficient amount and asked for adequate

amount of compensation. However, the Vice Chairman, JDA has again directed the Executive Engineer, JDA Div. No. I and II to frame the fresh estimate of compensation along with the site plan so that the adequate amount of compensation could be claimed from PWD Department. The copy of the aforesaid letter was also endorsed to the Commission and Vice Chairman, JDA, Jammu for information. The PIO had earlier furnished the information to the information seeker vide letter no. Secy/JDA/RTI/359/1204 dated 02-03-2013 which was not clear on the point whether plan of dismantled shops was provided to PWD Department, Jammu as required by in order to determine the amount of compensation to be paid to the affected allottees. The PIO informed the Commission that the site plan of the dismantled shops has been provided to the PWD Department, Jammu for further necessary action at their end. Thus, the information as requested by the information seeker stands furnished to him. No further direction in the matter is required.

The appeal is accordingly disposed of.
