Briefly the facts in this appeal are that Sh. Yog Raj S/o Late Sh. Prehlad Bhagat Sen R/o Zellana Kishtwar, Teh. & Distt. Kishtwar moved an application dated 15-04-2013 under J&K RTI Act, 2009 before the PIO NRHM, District Hospital, Kishtwar seeking certain information relating to functioning of Government Hospitals in Kishtwar. The CMO, Health & Family Welfare, Kishtwar filed a counter statement before the Commission vide no. CMO/K/RTI/2819-20 dated 10-09-2013 in which he submitted that his office had not received any kind of application of the appellant directly or under a registered cover as stated by him and it is evident from the fact that the RTI application does not contain any acknowledgement receipt of the CMO's office. However, a letter from Mission Director, NRHM J&K vide no. SHS/J&K/NRHM/7115-16 dated 03-06-2013 was received in the office of CMO, Kishtwar through fax where under 1st appeal for non furnishing of information was sought. The said letter was found without its enclosures. After that the office of CMO, Kishtwar wrote a letter to Mission Director on

04-06-2013 for issuance of application of the appellant along with its enclosures for further necessary action. Mission Director, NRHM J&K vide his letter no. SHS/J&K/NRHM/2642-43 dated 08-06-2013 provided a copy of application along with their enclosures and consequently after receiving that application it was forwarded to Medical Superintendent District Hospital, Kishtwar / BMO, Kisthwar / BMO, Paddar / BMO, Dachhan / BMO, Chatroo vide office letter no. CMO/K/998-1002 dated 10-06-2013 for submission of reply within two days positively. The CMO, Kishtwar further submitted that all the drawing and disbursing officers of Health Sector District, Kishtwar has furnished the desired reply of the said RTI directly to the applicant with a copy to this office as well.

During the course of proceedings, the CMO, Kishtwar informed the Commission that information as available in office record was sent to the information seeker under registered cover on 22-08-2013 including a CD containing the requisite information sought by the information seeker. The perusal of the aforesaid facts shows that information sought by the information seeker stands furnished to him and as such no further direction in the matter is required.

The appeal is accordingly disposed of.
